*Notes:*

1. The average daily parcel volume is calculated by dividing the total parcel volume by the number of calendar days in the corresponding period, which is 90 days and 91 days for first quarter of 2025 and the first quarter of 2024, respectively;
2. Except for the number of sorting centers and automated sorting machines, other data is rounded to the nearest approximation;
3. The business model in the new market is still being explored and optimized, and is not disclosed here;
4. The decrease in the number of network partners and outlets in China was mainly due to that the Company optimized the network structure in China to enhance the operating capacity of single network partner and outlet;
5. The increase in the number of outlets in SEA was mainly due to that the Company increased new outlets to enhance network capacity and efficiently handle the rapidly growing volume of parcels;
6. The decrease in the number of outlets in new markets was mainly due to the Company's optimization of outlets based on the business conditions in different countries;
7. The increase in the line-haul vehicles in SEA was mainly due to the rapid growth in the Company's parcel volume during the Ramadan shopping festival, which boosted the demand for line-haul vehicles;
8. The decrease in the number of line-haul vehicles of third-party carriers in China was mainly due to the seasonal fluctuations in parcel volume and the Company's increasing the use of high-capacity vehicles.

**Please note that all figures above are unaudited and have not been confirmed by the Company's auditors and may be subject to adjustment and final confirmation. Shareholders and potential investors of the Company are advised to exercise caution when dealing in the shares of the Company.**
